- b) 2024 Budget
  - i) Review 2024 Budget.
    - (1) Jay recapped the budget amounts that were discussed at the hearing/workshop. The amount to be collected for the 2024 budget is \$136,000, this is an increase of \$14,000 over 2023 budget. Per parcel rate for 2024 should be approximately \$82.22, annually made in two payments April and October \$41.11. Per parcel monthly cost \$6.85. Per parcel annual rate increase is \$8.46, from 2023. This calculates to a per parcel increase of about \$0.705 cents per month.
  - ii) Theresa made a motion to approve the 2024 Budget, Bruce seconded, all in favor, motion carried.
